9. Background:

FTA has solicited proposals for planning and implementation plans under the Alternative Transportation in the Parks and Public Land Program for FY 2006 with a deadline of May 5, 2006. This program seeks to develop alternative forms of transportation on national refuges and parks to protect sensitive environmental lands such as the Ding Darling National Wildlife Refuge. The program is funded at \$21 million with no project to exceed \$5.4 million. There is no match requirement.

On Friday, April 7, 2006, representatives from Ding Darling National Wildlife Refuge, the City of Sanibel, US Fish and Wildlife and LeeTran held a conference call to discuss this opportunity. Based on the conference call, City of Sanibel Planning Staff requested authorization from their City Council to participate in the proposal development. The Sanibel City Council at their April 18, 2006 authorized the development a proposal. A tentative proposal is being developed seeking \$1.5 million in federal funding to develop a feasibility analysis, alternatives analysis, direct public involvement, and provide implementation guidance. As a designated FTA grantee, LeeTran is coordinating the effort to prepare a proposal. LeeTran seeks authorization to submit an application to the FTA. If LeeTran's proposal is successful, the Board will be asked to formally accept the award from the FTA.
