9. Background:

An additional mechanic position is needed to more effectively maintain the increased number of trucks in the Solid Waste Division. The Division has seen a marked improvement in rolling-stock effectiveness as a result of the landfill-based maintenance program. This position will provide for less down-time and will likely allow certain additional equipment to be serviced through this program

The increased volume of private commercial traffic and solid waste at the Hendry transfer stations has prompted the Division to divert private commercial solid waste directly to the Lee/Hendry Landfill. The new scale house position will operate the Lee/Hendry landfill scale house which was previously unmanned and open only to authorized Lee County contractors and County vehicles using a computer controlled weighing system.

Both positions were anticipated and budgeted for FY 06/07 but are now required for the remainder of FY 05/06. No additional funding is required for the current fiscal year (FY 05/06).

The anticipated positions are as follows, but the Division may revise the actual position titles and pay grades prior to advertisement.

- One, Solid Waste Mechanic
- One, Scale House Attendant
