At the January 24, 1990, Lee County Board of County Commissioners meeting, the Board approved and executed a License Agreement with Florida Power and Light. This enabled Lee County to develop and use a portion of the discharge canal site south of State Route 80 and east of the canal for outdoor recreational and park purposes. This park became known as Manatee Park that promotes Manatee awareness and education. Any modifications to the License Agreement must be formally approved and executed. The Board approved two prior modifications on August 22, 2000 and March 11, 2002. This third modification is necessary for the addition of a modular office building, septic tank, and landscape buffer that has been completed at Manatee Park.

THIRD MODIFICATION TO Manatee Park LICENSE AGREEMENT

THIS THIRD MODIFICATION TO LICENSE AGREEMENT is entered into this 31 st day of August, 2006 between Florida Power & Light Company, a Florida corporation ("Licensor") and the Lee County Board of County Commissioners, a political subdivision and charter county of the State of Florida ("Licensee").

RECITALS

WHEREAS, Licensor and Licensee entered into a License Agreement dated January 24, 1990 ("License") which granted to Licensee the right to use certain lands of the Licenser commonly known as the Ft. Myers plant discharge canal area for a park area for observation of manatees and other plant and animal life; and

WHEREAS, such License was set to expire on January 23, 2000, but the parties entered into that certain Modification to License Agreement dated August 22, 2000 which extended the License for a ten (10) year period beginning January 24, 2000 and expiring on January 23, 2010, with another ten (10) year option; and

WHEREAS, the parties entered into that certain Second Modification to License Agreement dated March 11, 2002, which granted to Licensee the right to construct a picnic shelter; and

WHEREAS, the parties desire to modify the License to allow for the addition of a modular office building and septic tank system; and

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree to modify the License as follows:

- 1. Park Design & Facilities. Section 5 of the License shall be modified to allow for the addition of a modular office building and septic tank system to the demised premises as shown on the attached Exhibit "A" incorporated herein by reference.
- 2. <u>Additional Improvements & Alterations</u>. Section 6 of the License shall be modified as Licensee shall add a landscape buffer to screen the modular office building visually from State Road 80. Said landscape plans are to be submitted to Licensor for approval prior to installation. Approved plans shall become **Exhibit "A-1"**.
- 3. <u>Notices</u>. Section 18 of the License shall be modified as any notices to Licensor shall be sent to:


