II. Approval of May, August, September, and November Meeting Minutes *Mark Tesoro*

• Cold Weather Activation and urgent human services requests were prioritized over completion of meeting minutes. CoC Governing Board Meeting minutes will be transcribed for board recommendation and approval as soon as possible.

III. HOT Team, Homeless Outreach Center and Severe Weather Plan Updates *Roger Mercado*

Roger provided updates on HVS initiatives.

- HOT Team is an active outreach partner with HVS providing resources to those they encounter experiencing homelessness. We have been able to get the team up and running in about 4 months, where typically this takes closer to a year, which speaks to our close working relationships with our community partners.
- Homeless Outreach Center working with TSA to open service center to provide resources and connections to housing for persons who are experiencing homelessness. Will be open 6 days per week, and include access to Behavioral Health and other resources. Anticipated opening date is in mid-January.
- Severe Weather Plan HVS will activate its Severe Weather Outreach plan in the winter when the EOC reports an extended period of cold weather of 40° or below. This outreach will include providing blankets, hot coffee and offering bus passes or transportation to shelter for the evening by coordinating with our local shelters to identify and if necessary expand capacity.

IV. Presentation: "Mobile Crisis Unit" -

JP Mojica

• JP Mojica from the Center of Progress and Excellence provided an explanation to the group about their Mobile Crisis Unit and the behavioral health support it provides to the community. The Mobile Crisis Unit is accessed by calling (844) 395-4432 and is in discussion with HVS to cover their Coordinated Entry lines for after hours and weekend coverage. This will make the Coordinated Entry line accessible 24 hrs. a day, 7 days a week.

V. Connect List and Housing Surge Plan –

Mark Tesoro

- The HVS housing process was reviewed with the board (Access, Assessment, Prioritization, and Referral).
- Connect List meetings (discusses cases of vulnerability not captured by the VI-SPDAT). Meeting are taking place weekly and have were reorganized to include –
 - Standardized documentation
 - New Technology in the form of communicating needs through Slack app.

- Hosted open forum for questions from HSV providers
- Housing Surge Plan (housing 100 households in 100 days)
 - After 100 days of this housing effort the group will take a 30 day break to assess progress and make corrections as needed, the process will then re-start for another 100 days.
 - This cycle will occur 4 times (totaling at least 400 clients housed over a 24 month period)
- Dashboard A visualization of the 100 x 100 effort is being created so the public can also follow the progress of campaign.

VI. Funding Updates and Housing Surge Plan

Jeannie Sutton & Mark Tesoro

- Grant agreements have been received from HUD for Continuum of Care funding. Those agreements have been routed for signature by the BoCC. Contracts with agencies are being executed simultaneously. Grant amendment for State ESG Cares funds is also being routed for signature. We expect grant agreements for federal ESG funding to arrive shortly.
- The written Housing Surge Plan was presented to the board and the plan of action was outlined. The goal of housing 100 households within 100 days, began December 1, 2020.

VII. Homeless Survey 123

Roger Mercado

• ArcGIS surveying is being conducted the last Wednesday of each month to provide HVS a snapshot of homelessness in the community. The data collected is not reported, but is used to help our outreach identify locations to focus services.

VIII. Agency Updates

- Janet Bartos provided updates from the Homeless Coalition. The Candlelight Vigil will be held December 21, 2020, on the Old Courthouse Steps.
- Sheila Dorsey provided updates for Jewish Family and Children's Services. Richard McDaniel will be manager of services, and the agency has procured office space in Lee County.
- Jeannie Sutton requested that members refer persons with lived experience to become Governing Board members.
