

# Recommended Lee Plan Amendments

#### Delete Map 14: Future Limerock Mining Overlay

- Limerock mines will not be identified on Map 14
- Location determined through rezoning process and LDC Chapter 12.

#### Eliminate Limerock Market Analysis Obligation

- Removes requirement to provide limerock to meet regional demand
- Removes ambiguities subject to legal challenges
- Demand determined by market conditions

#### Delete Objective 33.1 & Relocate To Goal 10

- Relocates clarified language
- Provides meaningful
   & predictable
   standards



## Findings

The proposed amendments have no impact on:

- Water supply protection
- Required maintenance and enhancement of animal habitats
- Evaluation of transportation routes and anticipated traffic to and from a mine

Deletion of Map 14 strengthens review of compatibility with nearby residential uses during the Mine Excavation Planned Development rezoning process

Locations for future limerock mining are limited based on:

- Resource availability mines will only locate where there is limerock
- Existing development patterns compatibility with nearby residential and conservation uses limit potential locations for limerock mining operations

LDC Chapter 12 provides comprehensive & rigorous regulations for mine applications to be approved

# Confirm the proposed amendments will have no adverse impacts on:

Reiterate that no mining requests are being approved by the proposed amendments

### State Reviewing Agencies Comments

#### Florida Department of Environmental Protection

Based on the review of the submitted amendment package, the Department found no provision that, if adopted, would result in adverse impacts to important state resources subject to the Department's jurisdiction.

#### Florida Fish and Wildlife Conservation Commission

We have **no comments**, **recommendations**, **or objections related to listed species and their habitat or other fish and wildlife resources to offer** on this amendment.

#### South Florida Water Management District

After an extensive review of the proposed revisions, the District has determined the changes do not appear to adversely impact the water resources within the District. The District has no comments on the proposed amendment package; however, the District offers the following technical guidance: The District acknowledges that future mining and development activity is not included in this comprehensive plan amendment. This review does not alleviate the need for District permits if future mining activities are proposed.

# Approval Process

#### Mine Excavation Planned Development (MEPD)

- **Pre-application meeting**
- **Staff Sufficiency Process** 
  - Staff reviews application to assure all required materials are present. Includes evidence of potential impacts to surface & groundwater, wildlife habitat, agricultural properties, & residential neighborhoods.
- Staff Substantive Review and Recommendation
  - Based on application materials staff develops recommendation based on the standards set forth in the Land Development Code.
- **Hearing Examiner Review and Recommendation** 
  - Staff & Applicant present substantive evidence & findings. Public has opportunity to address the Hearing Examiner and present additional evidence and testimony.
- **Board of County Commissioners Zoning Hearing** 
  - Staff and Hearing Examiner recommendation presented to BoCC.
  - Participants from the Hearing Examiner address the BoCC concerning the proposed rezoning.

#### **Mine Development** Order (MDO)

An MOD is a permit issued subsequent to zoning approval that allows the applicant to commence improvements to the mine site as a precursor to resource extraction and off-site hauling of extracted materials and active operation of accessory mine facilities (e.g. batch plants). The MDO is similar to a full development order (DO) approval under chapter 10.

#### **Mine Operations** Permit (MOP)

An MOP is the approval issued after staff confirms compliance with all conditions of the mine excavation planned development resolution (or underlying zoning approval if an existing mine) and site construction permit (MDO). Issuance of the mine operation permit allows extracted resource materials to be hauled off-site and commencement or operation of mining accessory uses and activities. A valid MOP is necessary to conduct mining activity starting with the initial excavation and continuing through completion of reclamation.

## Mine Excavation Planned Development (MEPD) Rezoning

Evaluation of Lee Plan consistency during the MPED process is strengthened by eliminating the requirement to be identified on Map 14.

#### LDC Chapter 12 provides comprehensive & stringent regulations for mining that address:

- Compatibility with surrounding land uses and natural resources
- Protection of surface and groundwater levels quality & quantity
- Preservation, enhancement or restoration of existing natural flowways
- Conservation of indigenous habitat areas occupied by wildlife
- Mitigation of transportation impact
- Long term monitoring

#### MEPD applications must be found consistent with all applicable Lee Plan provisions, including:


# Limerock Mining Areas

#### Traditional Alico Road Corridor:

- Unclear & undefined location
- Few remaining locations appropriate for limerock mining

#### Number of Mining Applications:

- A mining application's approval is not affected by Map 14's existence
- Limited by resource availability & existing land use patterns in Southeast Lee County



## Conclusions & Recommendation

#### The proposed amendments:

- ✓ No impacts to water supply, animal habitats or transportation.
- ✓ More stringent zoning compatibility review
- ✓ Limited availability of future mining sites
- ✓ Rigorous mining application process governed by LDC
